5. TECHNICAL LIAISON COMMITTEE REPORT

Technical Liaison Committee Report 2017/2018 (Winter program and seminar)

A very good and reasonably well attended winter lecture program, the subject matters have been very interesting and in keeping with industry OCCA represents. Attendance numbers were comparable to 2017.

The Monday night lecture programme has been modified slightly in the recent years to offer a mixture of social, semi social, visits and presentations. Higher attendance at visits would be welcomed.

The attendance numbers for the seminar were closely comparable to 2017. The seminar content was excellent, with a good balance of different industries and suppliers presenting.

11th September 2017 - Presentation at HMG

We were treated to a presentation by Paddy of HMG on social media in your business. This was well attended and presented on HMGs site. The presentation was followed by a Chinese meal at Glamorous in Manchester.

9th October 2017 – Presentation/Tour of Salford University

A tour and presentation of Salford University's facilities. This included presentations on the acoustics department and tours of analytical and the energy house. This was followed by a social meal at a Media city.

8. ELECTION OF NEW MEMBERS OF COMMITTEE None

9. ANY OTHER COMPETENT BUSINESS

The 2018 AGM was a pleasant departure to previous meetings as numerous subjects were discussed by all attendees, as detailed briefly below.

It has been decided by Committee to continue using Whitefield Golf Club as a meeting and lecture venue and the Chairman has managed to negotiate better room hire process for 2018/2019, the small meeting room rate has been reduced from £160 to £120 and the main room rate has been reduced from £250 to £200. A-M Etherington suggested the golf club is a good base for meetings, but the committee should also explore other venues for meetings throughout the year as we have done throughout 2017/2018, especially with new partnerships and links with academic organisations, as we may have the use of meeting room facilities free of charge. The University of Central Lancashire (UCLAN) will soon become the next educational

sponsor of OCCA, so the committee could possibly organise a Monday night lecture to be held at UCLAN.

A-M Etherington reported the Manchester Section has 155 active members, and 20 lapsed members (not paid subscriptions for the last year), of these members there are 111 ordinary members, 6 students and 37 with professional membership. The section already has one educational sponsor (University of Salford) with UCLAN signing up soon, the sponsorship fee is £800 and this grants two lecturers/professors membership and also allows up to 20 student members that will receive digital copies of SCI. OCCA and the Manchester section should nurture and encourage the student members to become full members in time and one way could be to tailor some Monday Night Lectures for students and apprentices.

The two current OCCA Educational sponsors (Leeds University and the University of Salford) will be exhibiting on the OCCA stand at Surfex this year; however they will be at either end of the stand and are not actually in competition for degree courses. Other ideas to encourage student members to play a more active role within OCCA would be for students to present papers or take placements within companies aligned with OCCA, such as corporate sponsors. Some other ideas were discussed to help increase membership such as an offer to sign up at Surfex and receive seven months membership for half price (the cost of six months membership).

The Manchester Section Seminar saw three new members sign up and also helped forge links with University of Salford students as several committee members and OCCA members (A-M Etherington, Mike Serene, Lee Sheridan, and Nikki Cosgrove) attended a lecture for final year students to discuss their experience within industry. Links with the University of Salford were further strengthened as two committee members (Mike Serene and Paul Sheppard) judged a chemistry competition held at the University. A-M Etherington sees the potential for future academic collaborations, especially with UCLAN as our contact at the university and previous seminar presenter (Claire Holt) is championing a centre of excellence for nano technologies, this could see even closer links within our industry and academia. OCCA should be pro-active in forging links with students, and not just at degree level but possibly helping schools and colleges with STEM (Science, Technology, Engineering and Maths) Ambassadors.

The meeting also agreed there should be more focus on increasing the number of professional members, and also questioning what professional membership means to members within the industry. It was suggested the committee should help educate and members regarding professional membership and actively promote the benefits, or advertise to non-members and students at events such as job fairs.

The past year has seen the committee trying different ideas for the Winter Lecture Programme, with social events, factory tours and less technical subjects, whilst still trying to provide several technical presentations. The committee find it can be difficult to strike a balance between a sales or technical presentation, and it can also be difficult to provide enough representatives from industry manufacturers to ensure presenters find their target audience.

The seminar feedback and general opinion of the meeting felt the 2018 seminar was not technical enough, and it was agreed that the committee should use the Winter Lectures to provide variety in terms of social and technical/non-technical presentations, whilst ensuring the seminar in March contains a predominantly technical content.

Other ideas regarding the Winter Lecture Programme were discussed including changing from the traditional Monday night to another day of the week for some lectures, or also try to arrange lectures during working hours. Some meeting attendees also had their own "wish list" of subjects they wanted to see during the lecture programme, so the committee should try and canvas the Manchester Section members to find the presentations our members would like to see. Finally it was suggested that the Manchester Section should not just restrict themselves to holding meetings and lectures close to Manchester as several attendees of the meeting would welcome events to be held in other areas such as Warrington, Preston or South Manchester.

All the comments and discussion have been welcomed by the attending committee members and they look forward to delivering some of the items discussed today.
